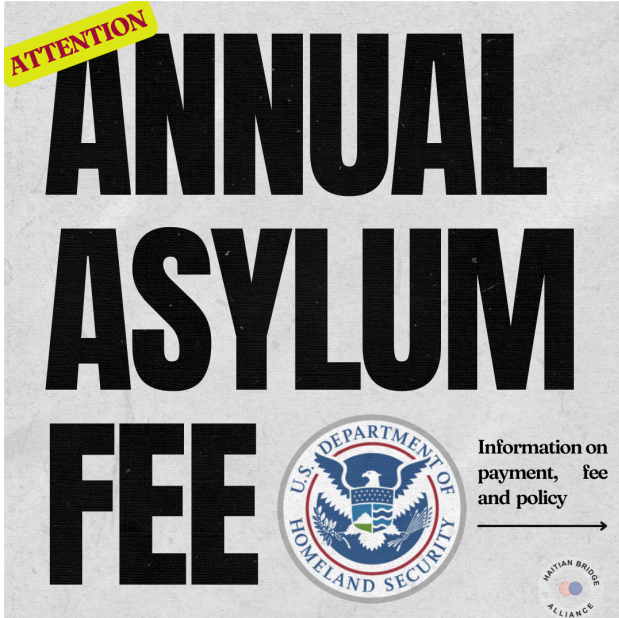

IMPORTANT NOTICE ABOUT ANNUAL ASYLUM FEES



IF YOUR APPLICATION IS AT USCIS

If your asylum application has been pending for over 1 year you must pay the new \$102 annual asylum fee by May 29, 2026 if it has not already been paid.

WHERE TO PAY:

<https://my.uscis.gov/accounts/annual-asylum-fee/questionnaire>

If you received a notice from USCIS to pay your annual fee, you must pay the annual asylum fee of \$102 on the website above.

You can also use this same website if it has been over 1 year since you filed for asylum, and/or you are unsure of whether you need to pay your annual asylum fee by entering your “A number” and the “receipt number” for your asylum application on this website.

Save a copy of your receipt of payment!

IF YOUR APPLICATION IS BEFORE THE IMMIGRATION COURT

For those in Immigration court, you must calculate whether your asylum application has been pending for over a year and/or follow your judge’s order to pay the fee.

WHERE TO PAY:

To pay the annual asylum fee, you can go to the Immigration Court Fee Payment website:

<https://epay.eoir.justice.gov/index>

Save 3 copies of your receipt of payment: (Immediately give 1 copy to the judge and 1 copy to the government attorney (DHS), and the last copy is for yourself!)



If you do not pay your annual asylum fee to USCIS by May 29, 2026, or by the deadline that the immigration judge sets in your case, your asylum application may be denied, and you may receive an order of removal.
